2008 Terms & Conditions for Sponsorship & Corporate Packages

1. Payment

- (a) Upon booking, you will receive an Tax Invoice with payment required by cheque, credit card (Visa / Mastercard) or Electronic Funds Transfer.
- (b) A deposit of 30% is due within 15 days.
- (c) The balance of payment must be received by March 15, 2008.
- (d) Tickets will not be issued till full payment is received.
- (e) Please make cheques payable to WA Reds RL Pty Ltd.

2. Changes, Withdrawal, Exclusion

- (a) Unforeseen circumstances beyond the control of the WA Reds RL Pty Ltd may require them to:
 - (i) change the dates or venue of game(s)
 - (ii) shorten the contract, or
 - (a) (iii) alter the Agreement with a Company.
- (b) WA Reds RL Pty Ltd will in their discretion reimburse any moneys that it thinks appropriate in any such alteration.
- (c) WA Reds RL Pty Ltd will not be liable for any loss or damage arising out any such alteration.

3. Indemnity

By signing this agreement you agree to indemnify WA Reds RL Pty Ltd against any loss or property damage to the venue and for any personal injury, death, loss or damage to any property or person arising out of the use of the facilities unless any such loss, damage, injury or death arises from any negligence or omission of the WA Reds RL Pty Ltd.

4. Cancellation or Default

- (a) All cancellations must be in writing
- (b) A fee for cancellation will be liable as follows:
 - Prior to March 1, 2008 30% of total cost contracted.
 - Prior to March 30, 2008 60% of total cost contracted.
 - After March 30, 2008 Full contract cost.
- (c) Companies who fail to comply with deadlines for payment of deposit and / or other payments for their contract or fail to fulfill their contract, may jeopardise their right to benefits, may have their contract details changed and be liable for full contract value.
- (d) Any costs incurred in recovery of payments will be charged to the Company. Late payment may incur a charge of 15% per annum for any overdue amount.

5. General

- (a) All facilities as part of the package agreed must not used for any other purpose than that for which the agreement is signed.
- (b) This agreement cannot be on sold or sub let to any other organisation other than the one as indicated without the approval of the WA Reds RL Pty Ltd.
- (c) WA Reds RL Pty Ltd, the stadium management and license holder of Members Equity Stadium reserve the right to refuse entry, or remove for the venue any patron who breaches the regulations of the venue and the license conditions.
- (d) All food and beverage must be purchased through the venue and no food or beverage can be brought into the venue.
- (e) Where facilities are closed or patrons are removed from the venue, the WA Reds RL Pty Ltd will deem that this breaches the contract agreement and will not be liable for any refund or loss or damages which result from any such action.
